

**NALS OF JACKSON COUNTY
CAROL A. WROZEK MEMORIAL SCHOLARSHIP
AWARD RULES AND REGULATIONS**

NALS of Jackson County shall present a \$500 non-renewable tuition/books-only scholarship available to those enrolled in a school of advanced education in the legal field. The scholarship will be awarded on the basis of scholastic or legal career achievements, future career goals, and leadership ability. The scholarship award may be granted to any qualified applicant in the legal field.

The applicant must be:

1. A high school senior or enrolled in a school of advanced education (including the current school year), with a grade point average of 3.0 or better.
2. A resident of the Jackson, Michigan-area and be enrolling in a Michigan school of advanced education in the legal field.
3. Able to enroll in the fall term (2020). Candidates nominated in prior years who meet current qualifications are eligible for renomination.

The application and all required attachments must be submitted on the form provided to the NALS of Jackson County Scholarship Chairman and must be received not later than **March 8, 2020**. **Any application received after that date or incomplete will not be considered. Emailed applications will not be accepted.**

The members of NALS of Jackson County will select a winner from qualified applicants.

Prior to submitting qualified applications to the membership, the NALS of Jackson County Scholarship Chair shall remove from each application all identification of the applicant and assign a number to each application. The Scholarship Chair shall retain in sealed envelopes bearing corresponding numbers, the identity of the candidates until the final decision has been made. The winner will be immediately notified to enable him/her to make arrangements for his/her ensuing school term, and be invited to a future NALS of Jackson County membership meeting. The scholarship winner must notify the Chairman of the school of choice and provide verification of enrollment. Upon verification of enrollment, a check will be submitted directly to the school of advanced education for the ensuing term in school. Any scholarship award must be used in full within one year from the date of written notification to the winning candidate of selection as a winner. Should the winner not enroll, the scholarship shall be forfeited.

THE NALS OF JACKSON COUNTY SCHOLARSHIP APPLICATION MUST BE FULLY COMPLETED WITH ALL OF THE FOLLOWING DOCUMENTATION ATTACHED AND RETURNED TO THE CHAIRMAN NOT LATER THAN MARCH 8, 2020.

- An Official Transcript of Grades [A Powerschool printout is NOT an Official Transcript].
- Personal Statement (1 page detailing your desire to pursue a career in the legal field and why you should be considered for this scholarship.)
- Two (2) one-page signed letters of recommendation. **Original signatures – No photocopies will be accepted.** One from a major teacher or counselor, and one from a person other than teachers, counselors, or family members to this application.
